FOREWORD



We have all witnessed and at times been directly affected by the series of recent crises which have adversely impacted the lives of EU citizens. The European Union and its member states have demonstrated their remarkable ability to respond swiftly and with unprecedented measures. Although substantial progress has been made, serious challenges still lie ahead. Our 2024+ work programme reflects our commitment to focusing our work on issues that directly impact the well-being of EU citizens.

The EU's response to these crises encompasses a range of policies that are supported by a substantial amount of funds available from the traditional EU budget and the recovery funds under the NextGenerationEU (NGEU) initiative. A significant increase in spending not only presents heightened budgetary risks, but also poses challenges to maintaining sound financial management and ensuring the effectiveness of public intervention.

Our 2024+ work programme has been drawn up with these challenges in mind. Our role as the European Union's independent external auditor is to check that the European Union's funds are raised and spent in accordance with the relevant regulations and rules, and that they achieve the intended results. You will find below a list of the **73 special reports and reviews** we intend to publish in 2024 and 2025. Furthermore, we will publish yearly our annual reports which represent the results of our financial and compliance audit work.

The Union's economic competitiveness is our first strategic area, and the subject of audit tasks such as digital transformation, artificial intelligence, and labour markets.

Security and migration are covered by our audit work under the strategic priority area *Resilience to threats to the Union's security, and respect for the European values of freedom, democracy and rule of law*, where we have audit tasks in areas such as aid for migrants and refugees, military mobility, and the rule of law.

Another important pillar of our audit programme is the **fight against global climate change** under the strategic priority area *Climate change, the environment, and natural resources*. We plan to publish reports covering a wide range of topics, including the development of smart energy networks, climate adaptation, and the LIFE programme.

Across all strategic areas, we plan to examine the **Recovery and Resilience Facility (RRF)**, covering topics such as control systems in member states, and the instrument's green and digital pillars. Several audits are also dedicated to another horizontal area: **combating fraud**.

While the EU budget continues to grow in scope and complexity, the ECA is dedicated to fulfilling its role in shaping the EU's financial landscape. Through our independent, objective and professional audit work, we are committed to safeguarding the financial interests of the European Union, and ensuring accountability in the use of public funds.

Our **vision**: We aim to be at the forefront of the public audit profession, and to contribute to a more resilient and sustainable European Union that upholds the democratic values on which it is based.

Our audit reports, reviews and opinions are an essential element of the EU accountability chain. They are used to hold to account those responsible for implementing EU policies and programmes: the Commission, other EU institutions and bodies, and national administrations.
