Foreword



In 2020, with new leadership in most of the EU institutions (the European Parliament, the European Council, the European Commission and the European Central Bank), and following the European Parliament elections, the EU stands at an important crossroads and must build on momentum to deliver results. Our role as the EU's independent external auditor is to check that the EU and its Member States deliver these results and that EU funds are raised and spent in accordance with the relevant rules and regulations, and correctly accounted for.

Although the EU's total annual budget of €140 billion may seem large, in budgetary terms it is quite small, accounting for just about 1 % of the gross national income of all the EU's Member States, whose total government spending is 50 times higher. It is therefore all the more important that the EU budget should be spent effectively, which is why our work increasingly focuses on assessing whether EU policies and programmes achieve their objectives and add value.

Our 2020 Work Programme, the last work programme under our current strategy, covers a broad range of issues that reflect the challenges the EU currently faces. It addresses the key concerns of the sustainable use of natural resources, growth and inclusion,

migration, security and global development, the single market, and an accountable and efficient EU. We will continue to examine all these areas in order to establish whether the EU is delivering what it has promised.

We have selected our audit tasks on the basis of an assessment of the main risks to EU spending and policy delivery, while also taking account of suggestions made. This year, and for the first time, we have identified some thematic focus areas to guide our audit work, such as science and technology, economic competitiveness, fiscal sustainability and the Eurozone, digitalisation and E-government, security threats, the rule of law and democratic values, migratory pressure, climate change, and social and economic imbalances in European societies. We will also examine the European Commission's assurance system for Cohesion for the 2014-2020 programme period.

Sustainability is high on the political agenda in the EU and its Member States, and so we have also put this at the heart of our work for the audit and review tasks starting in 2020. We will focus specifically on the actions undertaken by the EU in cooperation with Member States to meet the UN's Sustainable Development Goals (SDGs). Overall, all but three of the 17 SDGs are covered by at least one of these newly selected tasks for the 2020 Work Programme.

Lastly, we will continue to make every effort to limit the administrative burden of our audit work on our auditees.

Below you will find a detailed list of the special reports and review-based products we intend to publish in 2020.

We believe that the broad range of topics covered in our 2020 Work Programme will ensure that we can continue to provide EU citizens, and our institutional stakeholders and partners at both EU and Member-State level, with independent, objective reports on key issues for the future of the EU, highlighting what works well and drawing attention to what does not.

We are based in Luxembourg and employ around 900 audit, support and administrative staff of all EU nationalities. Our College is composed of one Member from each EU Member State.

Our mission is to contribute to improving EU financial management, promote accountability and transparency and act as the independent guardian of the financial interests of EU citizens. We warn of risks, provide assurance and draw attention to shortcomings as well as successes. We also offer guidance to EU policymakers and legislators on how to improve EU policies and programmes.

Our audit reports and opinions are an essential element of the EU accountability chain. They are used to hold to account those responsible for implementing EU policies and programmes: the Commission, other EU institutions and bodies and administrations in Member States.

Lastly, through our work, we want to help the EU's citizens to understand more clearly how the EU and its Member States are meeting current and future challenges.

We produce:

- annual reports on the EU budget and European Development Funds, including a Statement of Assurance;
- specific annual reports setting out our financial audit opinions on each of the EU's various agencies and bodies;
- an annual report on performance aspects;
- special reports on selected audit topics, published throughout the year, mainly as a result of performance audits;
- reviews, such as landscape reviews, briefing papers or rapid case reviews;
- opinions, which are used by the European Parliament and the European Council when approving EU laws and other decisions.
